Expiration Information

This application will expire 180 days from the submittal date. Any subsequent permits issued will be come null and void if work or construction authorized is not commenced within 180 days, or if construction or work is suspended or abandoned for a period of 180 days after work has commenced.

Plumbing Information

Plumbing Permit: I certify that all plumbing work will be done in accordance with applicable provisions of the City of Newberg Ordinances and Oregon Revised Statutes Chapters 447 and 693, and applicable codes, and that no help will be employed unless under ORS 693.

Development Information

Development Permit: In consideration thereof, the signee does hereby agree to pay the City of Newberg, the cost of sewer and/or water connection and development fees in accordance with City ordinances and resolutions. The signee does also acknowledge that a building permit will not be issued until the connection costs and development fees are paid in full. Applicant further understands that the City will begin billing in accordance with Resolution No. 93-1812, from the date of meter installation.
