Rob Molzahn, Newberg resident, spoke in opposition to car camping. He gave examples of homeless parking their vehicles illegally. He was concerned about safety and the program becoming out of control.

Timothy Brunner, Newberg resident, spoke in opposition to car camping. He thought the car camping program would create more problems than positives.

Mike Gunn, Newberg resident, thanked City Manager Worthey for his help in getting approval of a land use application. He was concerned about the unintended consequences to a car camping program.

CM Worthey explained this change to the sign code would reduce the burden on the City during election periods and keep City staff out of party politics. Residents would be allowed two flags and two signs to be displayed on their property.

He thought it was reasonable to allow two flags and two signs except in downtown where it was already too crowded with signs. He also thought some other changes should be made to the sign code.
