NOTICE OF FUNDING AVAILABILITY

The City Council approved the 2023-24 NOFA Funding Availability) for (Notice of (Construction Excise Tax) funds and directed city staff to proceed with notification and publication of the NOFA. The council put forth the goal of setting aside \$1 million of CET funds toward a "legacy project" which will potentially change destinies for Newberg families who earn less than 80% of the area median income by helping them to identify and remove barriers to home ownership and enabling them to save for a down payment. The mayor has recently begun meeting with a group of civic leaders to develop a program around these parameters.

FLOODING & RECOVERY IN CITY HALL

Following a report on the extensive flooding damage to all three floors of City Hall on Jan. 15, the City Council approved a resolution declaring a local state of emergency for 60 days (which was later extended for an additional 3 months). VIETNAM VETS FINALLY WELCOMED HOME

Mayor Rosacker read a Welcome Home Proclamation for Viet Nam Veterans, a very belated proclamation that was well received by the approximately twenty grateful Viet Nam veterans who attended.

MILITARY ASSISTANCE FUND INCREASED

The council approved an increase in the city's military assistance allotment, which is used to defray utility bills for families of active military service members. The budgeted amount was increased from \$3600 to \$6000 annually, which will allow 20 families to receive \$25 per month in assistance, an increase of 8 families.

REDWOOD & WHITE OAKS REMOVED IN the communications tower loan. MEMORIAL PARK

There are several known Redwoods throughout the Willamette Valley that are thought to have been planted 70 - 80 years ago. Frequently these were planted with little regard to their proximity to roads or structures already in place. A California Redwood and two White Oak trees located on the property adjacent to Memorial park near Blaine St, were examined by an arborist along with our Public Works Maintenance team, and the difficult decision was made to fell the trees to avoid massive costs of repairing or relocating Lea la versión en español del boletín en nuestro sitio a main stormwater line.

To retain the character of Memorial Park for future generations to enjoy, city staff planted 6 trees to include Oak trees. Additionally, the city is giving away all of the lumber from the Redwood to Newberg residents to use in building fences or other projects for the benefit of the community.

SAFETY CAMERA

City staff are still working on logistics with ODOT to enable the electrical cabinets required for the radarenforced safety camera project. Before any of these cameras "go live", the City of Newberg will work to ensure that local residents know where they are located, how they are expected to enhance safety at each intersection, and when enforcement will begin.

INTERSECTION ILLINOIS, N MAIN, & HWY 240

A \$60,000 study of this troublesome intersection was canceled. Rather than try to (again) determine a safer and more efficient design for that intersection, the decision was made to look at other possibilities, like

making Illinois a dead-end street at North Main. This action was taken intentionally to solve our problems locally instead of allowing ODOT to control the solution, which would most likely have resulted in a roundabout at significant cost to the city. Public outreach to the impacted neighborhood will begin in May.

FISCALLY CONSERVATIVE LEADERSHIP

As other cities are adding extra fees, payroll taxes and experiencing structural budget issues, Newberg is moving in the opposite direction. The three-year budget model projects the elimination of the communications officer fee from the municipal (utility) bill in 2026; This will be possible with the early payoff of At the same time, city leadership is committed to maintaining tight fiscal controls, enabling the projection of a healthy budget despite tough economic times. Our city's leadership thinks about money differently than our neighboring cities do.
