



## ELLIOTT ROAD IMPROVEMENT PROJECT Construction Schedule for Sewer Lining Work on N ELLIOTT ROAD

The Saunders Company and their subcontractor, Spartan Environmental Services, LLC., will be installing sewer liner to rehabilitate the existing wastewater conveyance (sewer) pipeline on N Elliott Road by Cured-in-Place Pipe (CIPP) method. Some of the pipe rehabilitation work needs to be performed at nighttime because of the higher sewer flow during daytime. The construction team has minimized night work to two consecutive nights. The daytime work is on schedule this week (after the Labor Day weekend).

Because of high school football home game this Friday, and ODOT not allowing traffic impact on Hwy 99W on Friday, the nighttime work is now rescheduled to next week. The sewer lining at the north end of N Elliott Road (at Newberg High School) is now scheduled for Sunday night 9/11/22. The sewer lining at the south end of N Elliott Road (at 99W intersection) will be on Monday night 9/12/22.

Doorhangers will be placed at businesses and homes impacted by the proposed sewer liner work. See below for the sewer rehabilitation work schedule†:

### September 6, 2022 through September 12, 2022

**Tuesday 9/6/22** – Day work on 8” diameter pipe from Apartments to Panda Express.

**Wednesday 9/7/22** – Day work on 8” diameter pipe from E Redwood Ct to Apartments.

**Sunday 9/11/22** – Night work on 12” diameter pipe from High School to E Haworth Ave.

**Monday 9/12/22** – Night work on 8” diameter pipe from Panda Express to HWY 99W.

There will be construction noises associated with this work. City staff and the construction team appreciates your understanding, patience, and cooperation for this work to proceed with minimal impact to sewer services.
