EXECUTIVE SUMMARY:

A. SUMMARY:

On August 2, 2021, the City Council held a noticed public hearing on the proposed Newberg Urban Renewal Plan and accompanying Report. Public testimony opportunity was provided. The Yamhill County Board of Commissioners Order/Resolution was included in the hearing (Attachment 1). That Order/Resolution approving the Plan was conditioned the Plan first having been approved by the voters of the City of Newberg at an upcoming election.

The Council continued the second reading of the Ordinance to October 18, 2021.

Later at the August 2, 2021, meeting, the City Council adopted Resolution No. 2021-3762 indicating their intent to go to an election on November 2, 2021, on the proposed Newberg Urbana Renewal Plan. On August 16, 2021, the City Council reconsidered their action of Resolution No. 2021-3762 and chose not to go to an election on November 2, 2021.

Rather than going to an election the city will be revising the urban renewal proposal. This revision will encompass completing the annexations underway for 5 properties in the Riverfront Master Plan Area, and a subsequent second annexation package for the ODOT Bypass and for the Newberg OR LLC (CDC) mill site.

Based on the direction the City is taking a second reading of Ordinance No. 2021-2885 is not necessary. A revised proposal will be prepared for creating an urban renewal plan and report in accordance with ORS 457 procedures and will proceed through the consult and confer process and noticed public hearings before the Planning Commission and Newberg City Council.

FISCAL IMPACT:

The urban renewal program development spanned several fiscal years. The total funds allocated for FY 19/20, 20/21, and 21/22. The urban renewal consultant project cost is \$97,891.00. The Community Development Department's 2019-2020 through 2021-2022 budgets in Fund 14 Economic Development included \$110,500 to fund the feasibility study, plan, and report, along with separate consultant services to prepare an urban renewal district legal description at \$12,558.00. The City Council was asked on October 18, 2021, to provide additional funding in the amount of \$20,000 to revise the proposed Newberg Urban Renewal Plan and accompanying Report based on the Yamhill County Board of Commissioners Order/Resolution requirements. Work began in December 2019 and will go through spring/summer 2022. Funding for the project was carried over to complete work in the 2021-2022 fiscal year.

An initial Newberg Urban Renewal Plan and accompanying Report were prepared. Based on the Yamhill County Board of Commissioners Board Order 21-317/Resolution 21-07-29-01 revisions will be necessary to the proposal. Those revisions will take additional time and financial resources. Staff will be reconvening the Urban Renewal Ad Hoc Committee, amending consultant contracts, and repackaging the proposal per requirements of ORS 457.

5. Collaborate with local partners and with entities like ICLEI in the development of a Sustainability program.
