As this area represents the gateway to Newberg, it seems like the first impression of a bunch of apartments right on the highway is not going to represent Newberg well. If such a development must go through then I would suggest additional landscape buffer restrictions that create a greenway along the highway so that we are not viewed as "apartment town". Hi Doug,

We have reviewed this PAPA for the SD/NC (Springbrook District/Neighborhood Commercial) area and, while we are generally supportive of the proposal and don't have any formal comments to add to the official record, we wanted to share the following recommendation with you for consideration:

The proposal includes modifications to land designated as open space along the Hess Creek Preserve corridor. DLCD staff recognize that the riparian area and wetland on site will still be preserved and the proposed pedestrian bridge across the creek is an allowed use in the city's code. However, if the Hess Creek Preserve corridor is identified as a Goal 5 resource site in the city's comprehensive plan, it would be prudent to include Goal 5 consistency findings in the documents/staff report supporting the amendment.

I am including Amanda Punton, DLCD's Natural Resource Specialist, on this email since she was the primary reviewer of this component of the PAPA record.
