

Property is in R1 Zone and will be used as a short-term vacation rental (STR). Owner occupies property part time and the proposed short-term vacation home rental is a single family residence (SFR) that was built in 1919. The house is 2,230 square feet and two stories with 3 bedrooms and 2 bathrooms. Property also has a 2 car garage with 2 parking spots in the driveway.

The location, design and site of this proposed STR will not generate any more traffic than long-term residents would living full time in the home. The proposed STF use will be consistent with ORD 2451, 12-2-96. Code 2001 151.210. and City of Newberg Municipal Code 15.445.300 - 15.445.350.

This proposed STR is a single family residence (SFR) that was built in 1919. The house is 2,230 square feet and two stories with 3 bedrooms and 2 bathrooms. There are also 3 parking spaces available on site - 2 in front of garage and one inside garage.



Prior to the conclusion of the initial evidentiary hearing, any participant may request an opportunity to present additional evidence, arguments or testimony regarding the application through a continuance or extension of the record. Failure of an issue to be raised in the hearing, in person or by letter, or failure to provide statements or evidence sufficient to afford the decision maker an opportunity to respond to the issue precludes appeal to the State Land Use Board of Appeals based on that issue.

The Planning Commission will make a decision at the end of the public hearing process. If you participate in the public hearing process, either by testifying at the public hearing, or by sending in written comments, we will send you information about any decision made by the City relating to this project.






