City creates historic preservation commission



The Newberg City Council has created the Newberg Historic Preservation Commission. The new commission will work to promote the preservation of historic buildings and sites in the community. It will review proposals for alterations of designat-

ed historic landmarks, and will consider the whether sites should be added or removed for the local landmark inventory.

The Council created the commission as part of an effort to become a Certified Local Government (CLG). The Certified Local Government program is a federal program (National Park Service) that is administered by the Oregon State Historic Preservation Office (SHPO) and designed to promote historic preservation at the local level. Once the city becomes a CLG, it will have access to grants, technical assistance, and training to improve the program.



Industrial urban growth boundary undergoing state review



The Newberg City Council and Yamhill County Commissioners have approved Inclusion of 132 gross buildable acres (260 total acres) into the Newberg Urban Growth Boundary (UGB). The land included

is along Highway 219 south of Wynooki Road and Wilsonville Road. The land will meet identified needs for industrial land through 2032.

The amendment also includes an update to the city's Economic Opportunities Analysis.

The UGB amendment is intended to provide opportunities primarily to expand the city's manufacturing sector.

The UGB amendment requires review by the Oregon Department of Land Conservation and Development Commission. They are currently reviewing the proposal. A decision from them is expected early next year.

Affordable housing grants and loan available




The Newberg Affordable Housing Trust Fund (NAHTF) has funding available for the current fiscal year ending June 30, 2014. Funds are available to organizations (non-profit and for-profit) and individuals that provide affordable housing and/or related services within Newberg. Funds are to assist with the creation/acquisition

of new affordable housing or the maintenance of existing affordable housing inventory within the community. Up to approximately \$3,500 in grants and \$56,000 in loans are available from the NAHTF. Grants are awarded through a competitive application process with applications due on Tuesday, December 31, 2013 at 4:30 p.m. Loan applications may be submitted to the City of Newberg through the competitive application process or anytime throughout the current fiscal year on an as-need basis.

Zoning use table adopted



Like most cities, Newberg has a zoning map that separates the city into different zoning districts, such as residential, commercial, and industrial. In addition, it has a zoning ordinance that specifies which uses are allowed in each of those districts.

In September, the Newberg City Council adopted a new zoning use table. This table organizes the lists of permitted and conditional uses in each zone into one table. The table is intended

to make the code more user friendly, and to insure more consistency in the code. The update also made several updates required to meet state law and to correct some inconsistencies and antiquated provisions.

The Council's adoption has been appealed to the state Land Use Board of Appeals.
